Participation Agreement (Page 1 of 2)

Please read this entire form carefully. Each participant is required to read, complete, sign and submit this agreement to *Magdalena Zukowski or Eleftheria Kakambouras / Lovelight Journeys*, prior to the commencement of this Retreat. Without an appropriately signed form, the individual will ***not be permitted to participate in the Program of this Retreat.***

I understand and accept the following terms and conditions for my participation in the A call To Sacred Wisdom Retreat in 2015 – *and all the relevant workshops on this retreat, events, sacred site visits and ceremonies.* (Herein after referred to as; “ACSW”):

I hereby acknowledge that I am over 18 years of age and of my own free will and desire I have contracted Eleftheria Kakambouras and Magdalena Zukowski (Herein after referred to as; “the provider”) to participate in “ACSW”.

I agree to pay the retreat fee in full prior to commencement of the retreat.

I understand and agree that should I withdraw from “ACSW”:

After the 7 day cooling off period, (day of purchase) but prior to the start of “ACSW”, then I am entitled to a refund of my retreat funds less the 1750.00 € non-refundable, non-transferable deposit.

After the start of “ACSW” then no retreat funds will be refunded.

You may transfer your retreat fee less deposit to another “eligible” person. This must be completed 7 days prior to start of the retreat.

I acknowledge that I have voluntarily chosen to participate in “ACSW” offered by Eleftheria Kakambouras. These activities include, but are not limited to: Personal and Spiritual development processes, Meditation, Yoga, Sacred Movement/Dance, Sacred Ceremony, Nature Hikes, Game Drives, Drumming, Campfire, Group sharing, Meditation Activations, and Sacred Wisdom Knowledge. I have full knowledge of the risks that these activities present, including travel to, participation in, and returning from the activities or events.

I understand and accept that Eleftheria Kakambouras, Magdalena Zukowski and persons associated with “ACSW” make no guarantee in relation to the specific outcomes I create throughout the program(s). I appreciate that the outcomes for all participants are personal awareness and empowerment. I also undertake to willingly participate and serve the above outcome in respect to myself and all other participants.

Should the facilitator deem that it is not in the best interest of either myself or the group that I continue to participate in “ACSW” then she is entitled to terminate my involvement at her discretion, in which case no tuition funds will be refunded.

I agree to respect the privacy and confidentiality of my fellow participants, including not soliciting anything from them or promoting anything to them during “ACSW” and following “ACSW” through the contact list that is made available to me (except with their express permission). I agree that any photos that I take during the retreat will not be made public (for example on Facebook) unless I have the express permission of the people in the photos. Should I break the agreement before, during or after the retreat, “the providers” reserve the right to restrict my involvement in any future Eleftheria Kakambouras or Lovelight Journeys International Seminars, Retreats or Trainings.

I acknowledge that I have voluntarily assumed any risk in entering this agreement and I release Eleftheria Kakambouras and Magdalena Zukowski, and any of their employees, servants and agents from any claims, demands, liability, actions and causes of actions arising out of my participation in “ACSW” including, but not limited to, any claim for personal injuries arising out of the negligence of “the providers” and of their employees, servants and agents.

Participation Agreement (Page 2 of 2)

I am fully aware that "ACSW" may involve a level of self-examination deeper than I have experienced before and that "ACSW" is based on a creative personal development model that works by setting up creative tension, and as a result has the potential to be personally confronting and distressing. I understand that participating in "ACSW" requires a basic level of emotional fitness and I consider myself to be emotionally and psychologically fit enough to participate.

I do understand that safe participation in "ACSW" requires reasonably good health, and I certify that I have no medical, emotional, psychological and/or physical conditions which could interfere with my safety in these activities.

If I am currently suffering from or being treated for depression, anxiety, psychosis or any other psychological or nervous condition, or taking any prescribed medication for the treatment or alleviation of the aforementioned conditions, I will inform "the providers" at the time of application for this retreat, prior to the commencement of "ACSW", and I understand and accept that "the providers" have the right to refuse my participation, in which case I shall receive a full refund of all retreat fees I have paid for the "ACSW".

I acknowledge that if I have failed to disclose to "the providers" and any of its employees, servants and agents any details of conditions from which I am currently suffering including depression, anxiety, psychosis or any other nervous or psychological conditions, or taking any prescribed medication for the treatment or alleviation of the aforementioned conditions, or a history of the aforementioned conditions I release them and any of the employees, servants and agents from any liability for any claims, demands, liability, actions and causes of action including, but not limited to, any claim for personal injuries arising out of the negligence of "the providers" and any of its employees, servants and agents. I acknowledge that any failure to disclose such information may prevent "the providers" from supplying services under the agreement that would be reasonably fit for their purpose and may adversely affect "the providers'" capacity to supply services of a reasonable nature and quality that might achieve a desired result from my participation.

I further understand and agree to assume responsibility for all risk of theft, loss, or damage of personal property which occurs at any time arising out of my participation in activities with "ACSW".

If any of the above clauses are severed from this agreement by any court or tribunal, in relation to any claims arising out of my participation, I agree that the total liability arising out of any such claim, whether as a result of the negligence of the parties or not, shall not exceed the full tuition fee for my participation in "ACSW".

This agreement is governed by the laws of The Republic of South Africa.
